9/15-19/01 Flowing back frac on 1/4" choke.

9/24/01 MIRU, ND frac valve, NU BOP. TIH with RBP retrieving tool.

9/25/01 Clean out sand from 4561' to RBP at 4650'. POOH with RBP.

9/26/01 TIH with 2-3/8" 4.7# J-55 production tubing, land at 6792', seating nipple at 6759'. ND BOP, NU wellhead. RDMO.
