The 4-1/2" casing was approx. 578' short of TD, because of circulation problems (see subsequent report dated 6/25/99 on 4-1/2" casing). Phillips wishes to RIH & cement a 3-1/2" 9.3# J-55 FL4S liner to TD. See below for brief details of the procedure we will use to set this liner.

MIRU. NU BOP & PT. RIH w/3-7/8" bit. Drilled out cement and 4-1/2" shoe @ 7811'. Circulate clean. RIH w/3-7/8" bit and cleanout well to TD @ 8390'. RIH w/hanger & 768' of 3-1/2" 9.3# J-55 FL4S casing. Land. RU BJ to cement. Pumped 10 bbls gelled water & then 60 sx 35/65 POZ with 6% gel, 10#/sx BA-90, 0.2% CD-32 and 0.5% FL-52 mixed at 12.3 ppg with yield of 2.12. Drop plug and displace with FW. COOH. RIH w/3-7/8" bit and cleanout cement to liner top. POOH. Circulate well clean with 2% KCl water. POOH. PT liner lap to 3000 psi. RD BOP & release rig.
