Mallon proposes to change the surface casing depth to 250 ft with cement circulated to surface. Mallon Oil Company feels that 250ft of surface casing will be more then adequate to protect any shallow water aquifers. Previous wells drilled by Robert L. Bayless in the East Blanco field utilized surface casing depths from 110'-160'. In the past year through our drilling program we have not encountered any water through or below these depths.
