Pumped 10 bbls mud clean, 10 bbls FW w/red dye. The pumped lead cement - 425 sx (1005 cf) Type 3 Cement 35.65 POZ w/5#/sx Gilsonite, 1/4#/sx Cello-flake, 6% gel, 10#/sx CSE, 3% KCL, 0.4% FL-25, 0.02#/sx Static free mixed at 12.0 ppg w/2.37 yield. Tail pumped - 100 sx (140 cf) Type 3 cement w/1/4#/sx Cello-flake, 1% CaCl2, mixed at 14.5 ppg w/1.4 yield. Dropped plug and displaced w/126 bbls water. Plug down at 0600 hrs 4/22/00. Circulated 1 bbls (5.6 cf) cement to surface.

ND BOP & equipment. Set slips and cut off 7" casing. NU BOPs, choke manifold & lines. PT 7" casing, rams, manifold, and lines to 200 psi for 3 minutes and 2000 psi for 10 minutes. Good test
