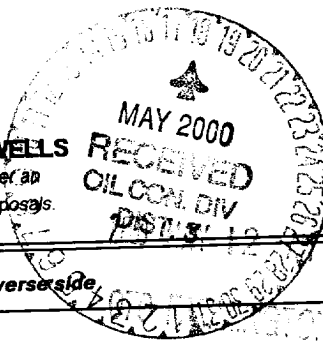

RIH w/6-1/4" bit & tagged cement @ 3070'. Drilled cement from 3070' to 3120'. Drilled new formation to TD @ 3269'. TD reached 4/23/00. Rotated and reciprocated, then surging well for approx. 13 days. RIH & tagged fill @ 3267'. Cleaned out to 3269'. COOH. RIH w/5-1/2" 15.5# J-55 casing (liner) - 179.7'. Set liner @ 3271' with hanger top @ 3083'. COOH. RU Blue Jet & perf'd liner @ 4 spf .75" holes.

3229' - 3269' = 40' = 160 holes.

RIH w/2-3/8" 4.7# J-55 tubing and set @ 3240' w/"F" nipple set @ 3208'. ND BOP & NU WH. PT - OK. Pumped off check. RD & released rig 5/9/00. Turned well over to production department to first deliver.
