RU Halliburton and cement 1st stage with 225 sks. Poz "H", 2% gel, .3% Halad-344, 2% CaCl₂, 10#/sk gilsonite, 1/4#/sk flocele(329 cu. ft.). Plug down @ 4:30 PM 9/29/00. Open stage tool and circ. 35 sks. cement to surface. Cement 2nd stage with 625 sks. "H", 6% gel, 10#/sk gilsonite, 1/4#/sk. flocele, 2% CaCl₂(1225 cu. ft.), followed by 100 sks.
