Pumped lead - 510 sx (1209 cf - 215 bbls slurry) Type 3 35:65 POZ w/5#/sx Gilsonite, 1/4#/sx Cello-flake, 6% gel, 10#/sx CSE, 3% KCL, 0.4% FL-25, 0.02#/sx Static free. Tail - pumped 50 sx (69 cf 12.48 bbls slurry) Type 3 w/1/4#/sx Celool-flake, 1% CaCl2 mixed @ 14.5 ppg, 1.40 yield. Dropped plug and displaced w/160 bbls FW. Plug down w/560#, 2 bbls (11.2 cf - 4.7 sx) cement circulated to surface.

ND BOP, set slips and cut off 7" casing. NU BOP, lines & manifold. PT rams, and casing to 200 # - 3 minutes and 3000 # - 10 minutes. Good test.
