

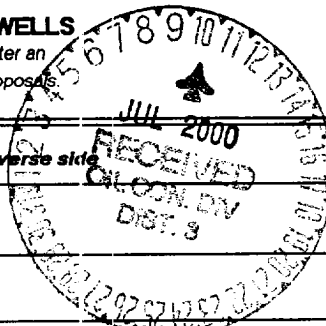

Pumped tail - 50 sx (63 cf - 11.20 bbls slurry) Class H cement w/1/4#/sx Cello-flake, 5#/sx Gilsonite, 0.3% FL-25, mixed at 15.2 ppg, 1.26 yield. Dropped plug & displaced w/122.5 bbls FW. Plug down at 0242 hr 6/4/00 w/1350 #. Check float. Held good. No fluid returns to surface. WOC. ND & PU BOP. Set slips & cut off 4-1/2" casing. RD & released rig 0600 hrs 6/4/00.
