Pumped 10 bbls mud clean and 10 bbls FW w/red dye in last 5 bbls. Pumped 165 sx (41.49 bbls slurry) 233 cf of Type 3 cement w/2% CaCl₂, 1/4#/sx Cello-flake, mixed at 14.5 ppg w/1.41 yield. Dropped wood plug & displaced w/21.5 bbls FW. Left 30' of cement in casing. Plug down 0918 w/140#. Had 8 bbls (44.9 cf) cement circulated to surface. WOC. NU BCP. Test casing, rams and manifold to 200 # 3 minutes and 1500 # 10 minutes. Good test.
