DRILL A 6" X 300' DEEP WELL GROUND BED AND LOAD WITH 8-15 2" X 60" ANODES BACKFILLED WITH 2500 LBS. LORESCO SWS COKE BREEZE. THIS GROUND BED WILL HAVE A MINIMUM OF 20' OF 8" PVC CASING. WORK TO BE PERFORMED ON LOCATION. A SOLAR POWER UNIT WILL BE INSTALLED AND ONE CABLE WILL BE TRENCHED FROM THE SOLAR UNIT TO THE WELLHEAD.
