Pumped 2% KCL water, gelled water ahead of 265 sx (591.8 cf - 105.4 bbl slurry) Type 3 cement 35/65 POZ w/6% Bentonite, 10#/sx CSE, 0.02#/sx Static Free, 1% FL-52, 0.3% CD-32, 0.3% R-3, 1/4#/sx Cello-flake. Tail - 50 sx (62.9 cf - 11.2 bbls slurry) Class H cement w/1/4#/sx Cello-flake, 5#/sx Gilsonite, 0.3% FL-52. Dropped plug & displaced w/129.5 bbls FW. Plug down at 0900 hrs 7/2/00 with 1200 psi. WOC.
