SPUD REPORT 8/20/01 MIRU Key Energy #47. Spud 12-1/4" hole @ 2100 hrs 8/20/01. Drilled ahead to 348'. Circ. hole. Rih w/9-5/8", 32.3#, H-40 casing and set @ 348'. RU to cement. Pumped a preflush of 10 bbls mud clean & 10 bbls dye water and then pumped 220 sx (310 cf - 55.20 bbl slurry) Type 3, 2% CaCl2, 0.25#/sx Cello-flake. Displaced w/25 bbls H2O. Plug down @ 1306 hrs 8/21/01. NU WH & BOP. PT BOP, rams, manifold and casing to 200 psi low and 1500 psi high. Good test.

NOTE: This is the 2nd submittal of this sundry the first was dated 8/22/01 and was accidently rejected by the BLM. They showed this API number for the 31-6 #54 which was the original name for this well, but the name was changed to the 31-6 #8M when we decided to add the DK interval & complete this well as a commingle well.
