Pumped 10 bbls mud clean, 10 bbls FW spacer w/dye. Then pumped Lead - 430 sx (1022 cf - 182 bbl slurry) Type 3 cement 35/65 POZ w/3/sx Gilsonite, 1/4#/sx Cello-flake, 6% Gel, 10#/sx CSE, 3% KCl, 0.4% FL-25, 0.02#/sx Static Free. Tail - 50 sx (70 cf - 12.5 bbl slurry) Type 3 cement w/1/4#/sx Cello-flake, & 1% CaCl2. Dropped plug and displaced w/123 bbls FW. Plug down @ 1203 hrs 12/19/00. Circ. 15 bbls cement to surface. WOC. ND BOP, set slips and cut off casing. PT casing, rams, & valves and manifold to 200# - 3 minutes and 1800# 10 minutes. Good test.
