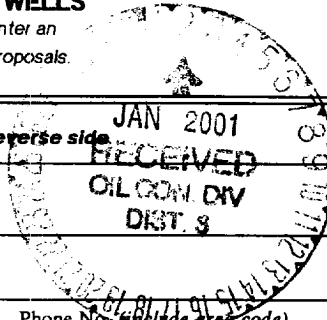

Pumped 10 bbls mud clean, 10 bbls FW w/red dye. Then pumped 105 sx (146 cf - 26 bbl slurry) Type 3 cement w/2% CaCl2 & 1/4/sx Cello-flake. Dropped wood plug and displaced w/15.8 bbls of FW. Plug down @ 0157 hrs 12/16/00. Circ. 3 3 bbls cement to surface. WOC. NU WH & ND BOP. PT casing, rams, manifold & lines. Good test.
