RIH w/6-1/4" bit & drilled out cement, then drilled ahead to TD @ 3224'. TD reached 12/21/00. Circ. hole. Load hole & Blue Jet ran GR/CCL/CBL, then shot string shot bombs into coal interval to breakdown. RD Blue Jet. RIH w/bit & C/O fill. Rotated and reciprocating to TD. R&R for approx. 11 days using air, mist & water sweeps. Cleaned out to TD. COOH. RIH w/5-1/2' 15.5# J-55 liner & set @ 3223' with top of hanger set @ 3038' (38' overlap into 7" casing). Perforated Liner @ 4 spf .75" holes as follows:

3125'-3132'(7'); 3160'-3167'(7'); 3196'-3222' (26'); Total 40' = 160 holes.

RIH w/2-3/8", 4.7# tubing and set @ 3192' with "F" nipple set @ 3160'. ND BOP & NU WH. PT-OK. Pumped off expendable check & RD & released rig 1/4/01. Turned well over to production department to first deliver.
