Pumped a preflush of 5 bbl 2% KCL, 5 bbls gel water and 5 bbls 2% water, then pumped 1st stage lead - 25 sx (57.5 cf - 10.24 bbl slurry) Premium Lite HS, 3#/sx CSE, 0.2% CD-32, 0.75% FL-52, 1#/sx Gilsonite, 0.25#/sx Cello-flake; Tail - 50 sx (116.5 cf - 20.74 bbl slurry) Premium Lite HS, 0.2% CD-32, 0.75% FL-52, 3#/2s CSE, 4#/sx Pheno-seal, 1#/sx Gilsonite, 0.25#/sx Cello-flake, 0.3% R-3.

2nd stage - Lead - 220 sx (510.4 cf - 90.90 bbl slurry) Premium Lite HS FM, 0.2% CD-32, 0.75% FL-52, 3#/sx CSE, 2.5#/sc Pheno-seal, 1#/sx Gilsonite, 0.25#/sx Cello-flake, 0.1% R-3; Tail-25 sx (46 cf - 8.19 bbl slurry) Premium Lite HS FM, 0.2% CD-32, 0.75% FL-52, 3#/sx CSE, 4#/sx Pheno-seal, 0.25#/sx Cello-flake. Displaced w/122 bbls H2O. Plug down @ 1543 hrs 2/25/02.

ND BOP, Set slips. RD & released rig 0000 hrs 2/26/02. Will report TOC and 4-1/2" casing pressure test on next report.
