Open stage tool & circulate trace of cement to surface. Cement 2nd stage with 730 sks 65/35 Class B poz, 10#/sk gilsonite, 1/4#/sk flocele, 6% gel, 2% CaCl2 (1430 cu.ft.) followed with 50 sks 50/50 Class B poz, 5#/sk gilsonite, 1/4#/sk flocele, 2% gel, 0.2% CFR-3, 0.5% Halad-9 (66 cu.ft.). Plug down @ 7:45 pm on 05/20/02. Circulate 100 sks cement to surface. RD Halliburton. ND BOP. Rig released 9:30 pm on 05/20/02.
