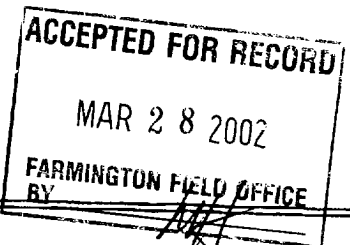

Pumped a preflush of 10 bbls mud clean & 10 bbls dye water ahead of 200 sx (282 cf - 50.22 bbl slurry) Type 3, 2% CaCl₂, 0.25#/sx Cello-flake. Displaced w/25 bbls H₂O. Plug down @ 2035 hrs 3/24/02. Circ. 15 bbls cement to surface. NU WM & NU BOP. PT BOP, rams, lines, manifold and casing to 200 psi low and 1500 psi high. Good test.
