Tail - 50 sx (116 cf - 20.65 bbl slurry) Premium Lite High Strength FM, 0.2% CD-32, 0.75% FL-52, 3#/sx CSE, 4#/sx Pheno-seal, 1#/sx Gilsonite, 0.25#/sx Cello-flake, 0.3% R-3.
