Pumped a preflush of 10 bbls H2O, 10 bbls mud clean, 10 bbls dye water ahead of Lead - 500 sx (1205 cf - 214 bbl slurry) Premium Lite High Strength FM, 3#/sx CS#, 3% KCl, 0.4% FL-25, 0.25#/sx Cello-flake, 4#/sx Phenon-seal, 5#/sx Gilsonite.

Tail - 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl2, 0.25#/sx Cello-flake. Displaced w/143 bbls H2O. Plug down @ 1309 hrs 3/4/02. Circ. 20 bbls cement to surface. ND BOP, set slips and cut off casing. NU BOP - PT OK. RIH w/bit & then PT casing, to 200 psi low and 1500 psi high. Good test.
