Acidized perfs w/1500 gal 7-1/2% HCl. RU to frac. Pumped 46,410 gal of 60 Quality Spectra Frac 3000 consisting of 20,500 gal of 30# X-link gel & 794,000 scf N2. Pumped a 1000 gal foam pad followed by 2000 gal of foam containing 4500# of 100-mesh sand. Pumped 43,410 gal of foam containing 100,200# of TLC 20/40 Proppant. Flushed w/2950 gal foam. Flowed back on 1/4" and 1/2" chokes. RD flowback equipment.

Kill well w/2% KCL. RIH w/bit & tbg & C/O sand to PBTD @ 7868'. COOH. RIH w/2-3/8", 4.7# tubing and set @ 7802' with "F" nipple set @ 7795'. ND BOP, NU WH. Pumped off expendable check. RD & released rig 4/29/02. Turned well over to production department.

This well will be DHC'd. We will flow the DK until pressure stabilize and then we will return and complete the MV interval, flow it till it stablizes and then will DHC per Order #11363. A DHC application for this well will be submitted before actual comminglin occurs.
