Pumped a preflush of 10 bbls water, 10 bbls SAPP, & 10 bbls dye water ahead of Lead - 550 sx (1325 cf - 235.97 bbl slurry) Premium Lite Strength FM, 3#/sx CSE, 3% Potassium Chloride, 0.4% FL-25, 0.25#/sx Cello-flake, 4#/sx Pheno-seal, 5#/sx Gilsonite.

Pumped Tail - 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl2, 0.25#/sx Cello-flake. Displaced w/147 bbls H2O. Plug down @ 12:26 hrs 4/7/02. Circ. 30 bbls cement to surface. WOC. ND BOP, Set slips & cut off casing. PT casing to 200 psi low and then 1500 psi high for 30 minutes. Good test.
