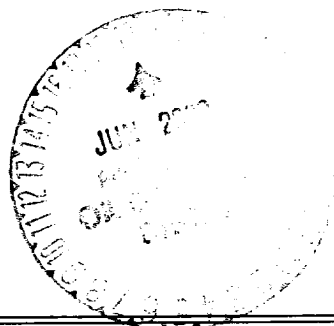

Test casing & BOP to 600 psi - ok. BLM notified- no witness.
