The tubing in the subject well was stuck at 5637' and subsequently cut at 5635'. A cast iron bridge plug was set at 5625'. Set a Baker Lohr packer at 5940', acidized the Gallup zone 5987-94' with 500 gallons 15% mud acid and put on pump. Latest test was 3 BOPB and 7 MWPB.

Instructions
