Plug #1 w/63 sx Class "B" neat cmt w/2% calcium chloride. Displace  
from 1644' to 1094'. TOOH. WOC. TIH w/wireline, tag plug #1 @  
1168'. Perforate 2 holes @ 440'. TOOH w/wireline. TIH, set cmt  
retainer @ 380'. Pump 150 sx Class "B" neat cmt. Squeeze 104  
sx below cmt retainer, circ 46 sx from 380' to surface. TOOH.
