- 1. That the Aztec-Cain No. 1. Well, located 990 feet from the South line and 1480 feet from the West line of Section 31, Township 29 North, Range 9 West, was completed November 28, 1954 as a gas well and will be connected to Southern Union Gas Company's pipeline.
- 2. That the proposed non-standard gas proration unit consists of 197.19 acres which are contiguous lots.
- 3. That the proposed non-standard gas proration unit lies wholly within a signle governmental section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- 5.
