2. Pull out and laydown 177 joints. Pickup and run in hole to 5616'. Displace and balance 65sx, 77cf, 5616' to 5174'
3. Tag plug @ 5050'. Perforate @ 3188'. Displace and balance plug. 55sx, 65cf, 3188' to 2661'
4. Displace and balance 60sx, 71cf, 1590' to 1040'
5. Perforate @ 374'. Circulate 120sx, 141cf to surface.
