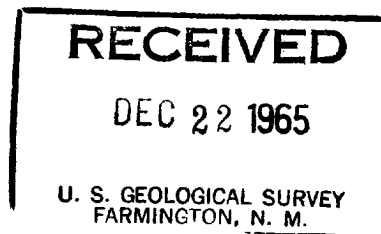

As a result of excessive water production on the subject Abrams Gas Com "B" No. 1, we moved in a well service unit December 17, 1965, pulled tubing and ran a casing inspection log. Casings found corroded from 350-360' and 510-590' with indicated hole at 708'. We propose to repair the casing by squeeze cementing from indicated hole to surface, test and return well to production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations; and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
