Establish circulation - test casing to 500 PSI - did not hold. Spot 15 sx cement on top. TOO H w/stinger. Tag cement @ 1360'. TIH w/retainer to 1240'. Establish circulation out of casing - test casing to 500 PSI - no test. Establish rate below retainer - no rate - spot on top. Spot 15 sx cement. TOO H w/stinger - tag @ 1113'. Shoot @ 293', establish circulation out of BH. Spot 120 sx cement and circulate 7 bbls cement to surface. Plugging complete.
