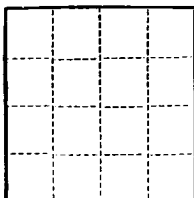

DETAILS OF WORK

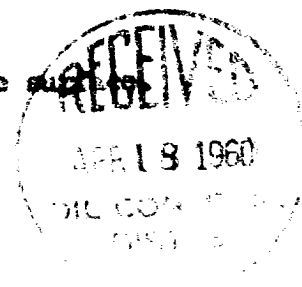

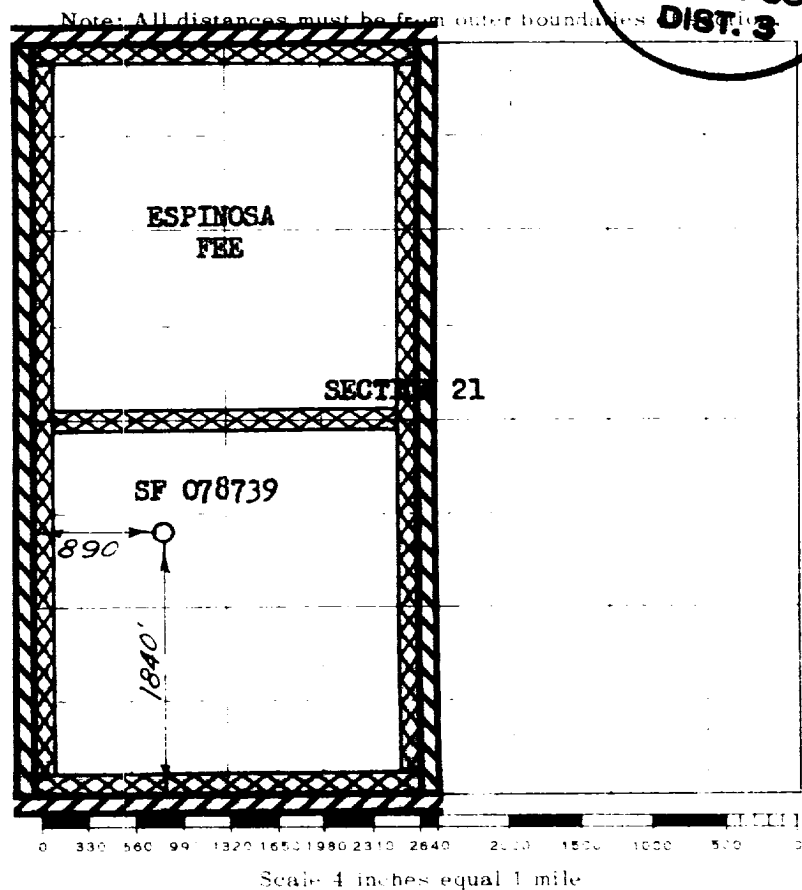
