Drilled 7 7/8" hole to 6140' ran 190 jts 4 1/2" O.D., 10.5#, J-55, 8R, ST&C special test casing, T.E. 6159.60' set at 6137'. Cemented first stage with 150 sx 8% gel, 50 sx Incon Neat. Cemented second stage through Baker two-stage tool at 1521' with 150 sx 12% gel. Good mud returns while cementing.
