DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

We run 2" tubing to a depth of 1740' and poured 50 sacks of cement into the Pictured Cliff Sands which would fill all open holes. Then we pulled 960' of 5 1/2" casing, filling the hole with drilling mud as we came up. After 5 1/2" casing was removed we used 17 sacks of cement, filling the top and setting 4" Marker as required by law.
