Kill Pictured Cliffs zone with water. 3. Perforate Fruitland zone 1616-1627 and 1642-1666 with 2 shots per foot. 4. Frac Fruitland with 30,000 gallons of water and 30,000 pounds of sand. 5. Run Baker Model "D" production packer. 6. Run 1-1/2" tubing to Pictured Cliffs. 7. Run 1-1/4" line pipe to Fruitland. 8. Swab in if necessary, blow to clean up and test Fruitland.
