TD 6365'. 4-1/2" casing was set at 6365' and cemented in two stages. Cemented first stage with 275 sacks 6% gel mixed with 1-1/2 pounds Taf Plug per sack followed by 100 sacks neat. Tested water shut off with 3000 psi for 15 minutes with no pressure drop. With stage tool set at 1890', cemented second stage with 500 sacks 4% gel. Circulated 45 sacks. Tested water shut off with 3000 psi for 15 minutes with no indication of pressure drop. Resumed completion operations.
