Well spudded December 25, 1961 at 1:00 P.M.

After drilling to 296' - on December 28, 1961 8-5/8" casing was set at 296'. Cemented with 200 sacks of cement, 2% calcium chloride. Started pumping plug down. Plug went down to 60' and stopped. This gave over 100 sacks of cement outside the casing. Ran 1-1/4" tubing down casing annulus and recemented with 100 sacks. Job completed at 2:00 A.M.

On December 29th - tested casing. O. K. to 800 p.s.i.. Resumed drilling with rotary rig.

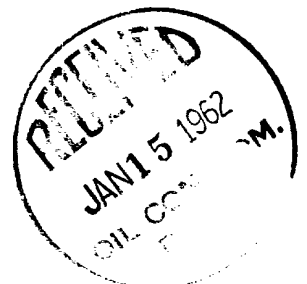
