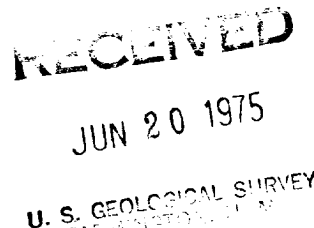
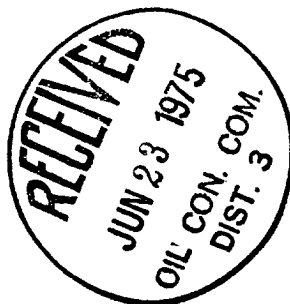

Due to the uneconomic status of the Garland "B" No. 1, a replacement well has been drilled. It is therefore intended to plug and abandon the subject well as follows:

1. Rig up and pull 1" tubing.
2. Run and set retainer at 1550 ft.
3. Squeeze open hole section from 1653 ft. to 1745 ft. with 25 sacks class "A" cement.
4. Perforate 5-1/2" casing at 700 ft. (100 ft. below Ojo Alamo)
5. Establish circulation and cement casing and open hole to surface.
6. Install dry hole marker.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
