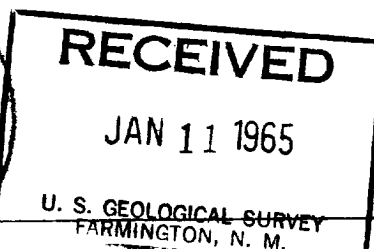

TD 5243', FBTD 5210', Perforations 5155-5171'.

Set BP @ 3825', cut off 5 1/2" casing @ 3759'. Pulled BP @ 3825', pulled 121 joints 5 1/2" 15.50# 8rd J-55 casing (3751'). Ran 114 joints 5 1/2" 15.50# casing (3751') with Bowen casing bowl with lead seal. Pressured to 1100#, held okay.

Sand pumped, recovering drilling mud and some shale. Swab tested, 24 hr. test 71 bbls. oil and 10 bbls. water. Production prior to casing leak, 138 b.o. & 20 b.w.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
