Dear Sir:

Your attention is directed to New Mexico Oil Conservation Commission Rule 1106 and 1108 concerning the filing of forms on wells drilled in the State of New Mexico. Rule 1106 states that Form C-103 shall be filed on all casing tests in triplicate within 10 days following completion of the test. This report should present a detailed description of the testing method employed and the results obtained by such test. Also within 10 days following completion fluid fracturing or other chemical treatment Form C-103 should be filed, presenting a detailed account of the work done. Rule 1108 states that within 20 days after completion of any well the owner shall file in quintuplicate Form C-105, the Well Record form, and should summarize all pertinent information as indicated.

We have received gas well tests on the above two wells and presume that they are completed. You are therefore in non-compliance with the above ruling. Will you please take immediate steps to comply with these regulations.

**Abstract**—The purpose of this study was to determine if there were differences in the prevalence of musculoskeletal disorders among different types of jobs. The subjects were 600 employees from a large manufacturing company who had been employed at least one year. They completed a questionnaire about their work activities and symptoms of musculoskeletal disorders. The results showed that the prevalence of musculoskeletal disorders was higher among workers in jobs that required heavy lifting, repetitive motions, and awkward postures than among workers in jobs that did not require these activities.
