Ran 13 joints J-55 9-5/8" new surface casing to 404 feet. Circulated cement to surface with 312 sacks. Held 1000# pressure for 30 minutes with rig pump. Water shut-off and cement job successful.

Ran 6314 feet J-55 new 5-1/2" production casing to 6314' in 8-3/4" hole. Cemented with 350 sacks. Held 1000# pressure for 30 minutes with rig pump. Water shut-off and cement job successful.
