Dear Sire

We are planning to drill the Haney Gas Unit No. 1, Aztec-Pictured Cliffs Field, in the SW/4, Section 20, T-29-N, R-10-W, San Juan County, New Mexico. It will be necessary, however, to drill the well on this tract at an unorthodox location due the width of the San Juan River through the area.

It is respectfully requested that Pan American Petroleum Corporation be granted administrative exception to well location requirements to permit drilling the subject well at an unorthodox location. The well has been staked 820 feet from the South line and 700 feet from the West line of Section 20, T-29-N, R-10-W, to provide a drillsite on dry ground on the south bank of the river. A well location plat is attached for your information and to illustrate the need for drilling the well at the indicated unorthodox location.

The SW/4 of Section 20 has not yet been communitized. However, we are attaching a copy of a telegram from El Paso Natural Gas Company, who holds the lease on NW/4 SW/4 Section 20, giving their approval for Pan American to drill the unit well on a lease basis subject to later execution of suitable unit instruments. Pan American holds the balance of the leases in the 160-acre tract. Also, Pan American is the owner of the oil and gas lease in S/2 SE/4 Section 19, adjacent to the west of the unorthodox location, which is the only offset tract closer than 790 feet to the proposed well.
