- P_c = 72 hour wellhead shut-in casing (or tubing) pressure whichever is greater. psia
- PwT Static wellhead working pressure as determined at the end of flow period. (Casing if flowing thru tubing, tubing if flowing thru casing.) psia
- Pt Flowing wellhead pressure (tubing if flowing through tubing, casing if flowing through casing.) psia
- Pf Meter pressure, psia.
- $h_{\mathbf{w}}$ Differential meter pressure, inches water.
- F_{g} Gravity correction factor.
- Ft Flowing temperature correction factor.
- $F_{\rm DV}$ Supercompressability factor.
