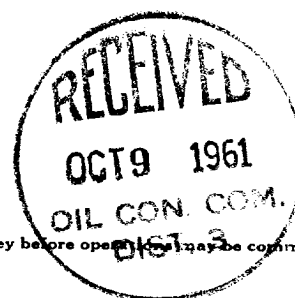

DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

Spudded 12-1/4" hole on October 1, 1961 and drilled to 291'. Set 8-5/8" casing at 290' with 250 sacks of cement containing 2 percent Calcium Chloride. Circulated 30 sacks of cement. After waiting on cement, tested 8-5/8" casing with 500 psi for 30 minutes, which held with no indication of pressure drop. Reduced hole to 7-7/8" at 291' and resumed drilling operations.
