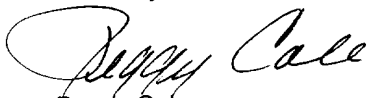

These percentages are based upon reserves assigned to each formation founded on production from the respective formations before and after workover operations and separator tests completed on the Chacra and Mesaverde formations. Since condensate production increased significantly with the addition of the Chacra and Mesaverde formations, condensate was allocated based on pre-work and post-work rates. 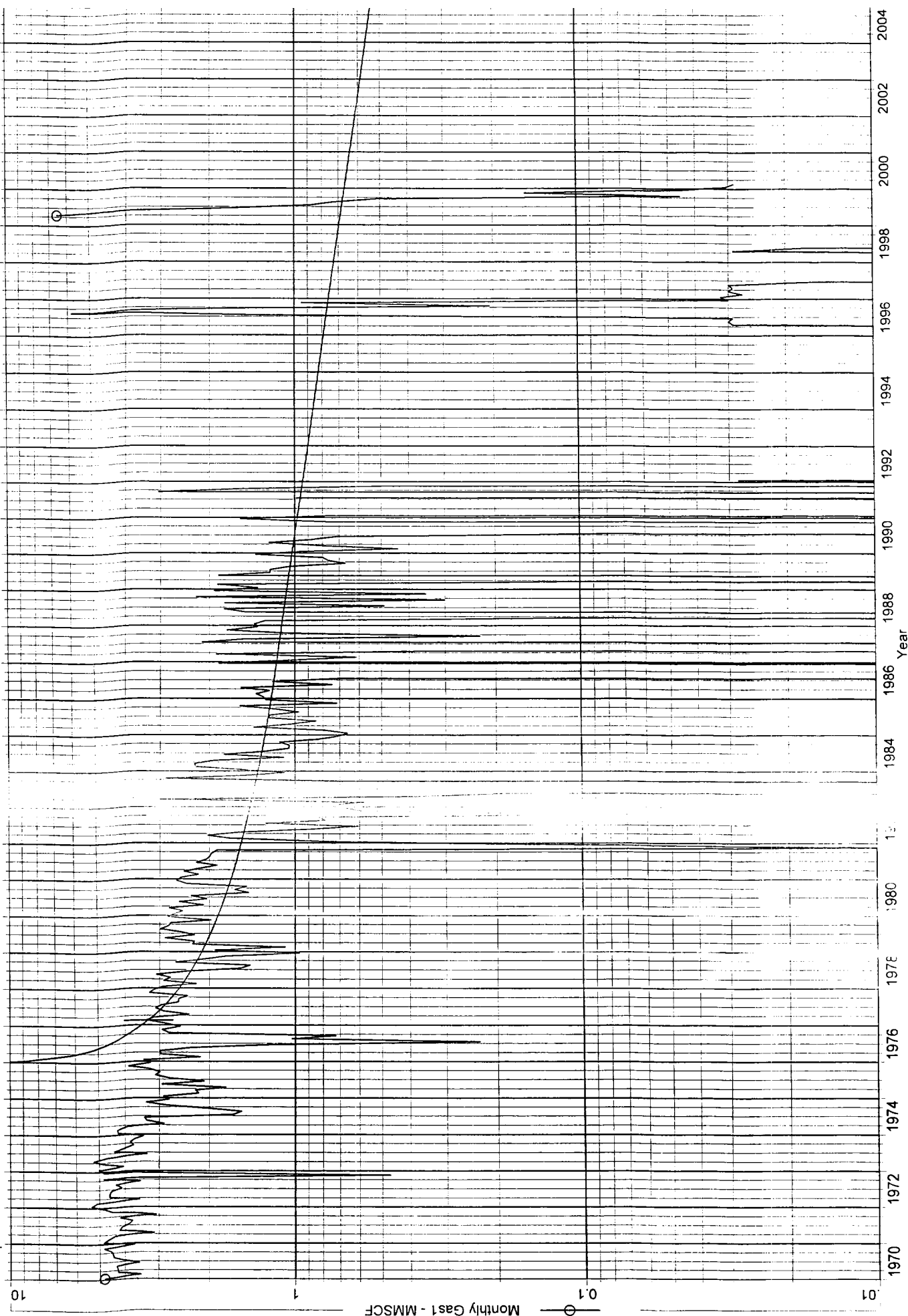
