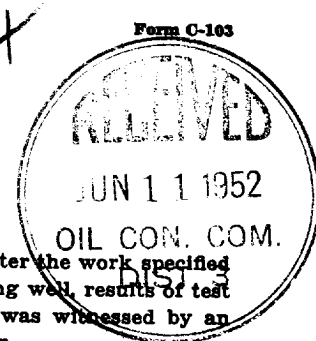


## NEW MEXICO OIL CONSERVATION COMMISSION
