We have received a request for bond cancellation on the Page & Davis #1 Salmon well in Section 22-29N-11W.

Since permission was granted to deepen the well we have not received any report of operations. An inspection of the well site by representatives of this office revealed that casing and/or tubing may have been run, that valves are on the well-head and that the well has not been plugged.

Therefore, release of the bond cannot be granted at this time.
