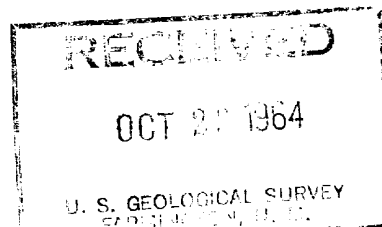
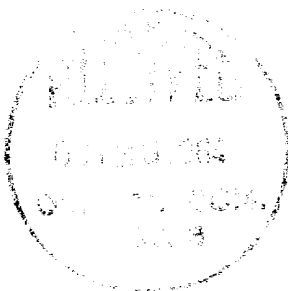

Cemented first stage w/400 aks. 1:1 Diamix "A" & Class "A" cement, 2% calcium chloride, 1/4# Cello-flake/sk. preceded w/67 cu. ft. PF-50. Second stage w/200 aks. 1:1 Diamix "A" & Class "C" cement, 1/4# Cello-flake/sk. Third stage w/200 aks. 1:1 Diamix "A" & Class "C" cement, 1/4 cu. ft. Strata-Crete "6" & 1/8# Cello-flake/sk. Top of cement by temperature survey at 1410'.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
