It is intended to drill a 4 1/2" section between zone in the following manner: Drill 7 7/8" hole to 30' and cement 1-3/4" casing with 70 sac. Drill 7-7/8" hole to total depth with 1 1/2" casing. If commercial production is encountered, cement 4-1/2" casing and plug zone with chemicals. Put well on production.

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

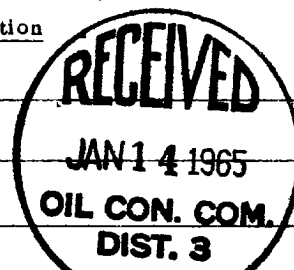

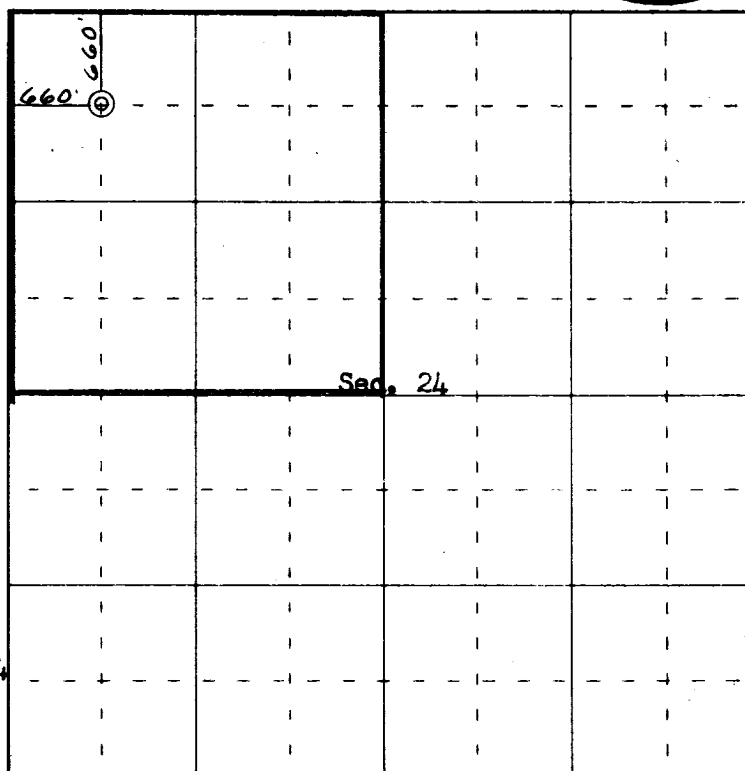
