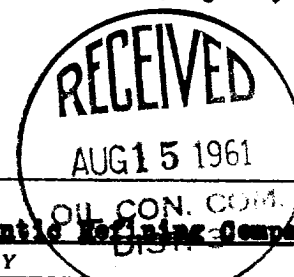

Detailed account of work done, nature and quantity of materials used, and results obtained.

Drilled 7-7/8" hole below surface casing to total depth of 6544' on July 19, 1961. Ran 204 joints of 4-1/2" O.D. 9.5# and 11.6# J-55 casing = 6531'. Set at 6543' and cemented with 275 sacks of 50/50 Pozmix plus 6% gel plus 12-1/2# Gillisnite per sack cement followed by 200 sacks of 50/50 Pozmix plus 2% gel followed by 50 sacks 50/50 Pozmix plus .9 gallon EA-2 per sacks of cement through shoe. (Total 856 cubic feet). Cemented with 400 sacks 50/50 Pozmix plus 6% gel through DV tool at 2040'. (588 cubic feet). Had complete returns while cementing and had contaminated cement returns to surface. W.O.C. 24 hours and drilled DV tool. Tested 4-1/2" casing with 3000# with 75# decrease in 30 minutes on July 22, 1961.
