DETAILS OF WORK

Drilled out from under surface pipe on 4-15-63. Drilled to 830' and cored from 830' to 876'. Drilled sand and shale to 4600'. Ran 146 joints 9 5/8" casing, landed at 4600' with stage collar at 981'. Cemented through shoe with 250 sacks regular and 150 cubic feet stratocrete. Cemented through stage collar with 140 sacks regular. WOC 24 hours. Pressured up to 2000 psi for 30 minutes, tested O.K. Preparing to drill ahead with air on 4-29-63.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
