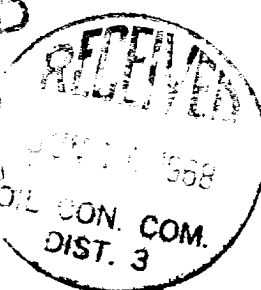

Set retrievable bridge at 2400' and packer at 1900'. Circulated with fresh water
to clean up. Pumped in 400 sacks 50-50 Pozmix cement with 2% gel, displaced
with 30 barrels of water. Let set 24 hours, drilled cement and cleaned out to
to 4629'. Pressure tested casing to 700#, held ok. Ran tubing and rods. Pump
tested for 39 BO & 137 BWPD.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
